Memo

Ministry of Health & Family Welfare, Government of India, has inter alia approved setting up of a medical college at Uluberia under the Centrally Sponsored Scheme- "establishment of medical colleges attached with district/referral hospitals" Phase-II.

WBMSCL has been entrusted to prepare DPR and carry out the creation of infrastructure in turnkey mode required for setting up of the medical colleges at Uluberia.

Finance Department, vide their U.O No. : Group O/2021-2022/0055 dated 2.11.2021 has kindly accorded in principle approval for setting up of Government Medical College and Hospital at Uluberia in West Bengal under Centrally Sponsored Scheme Phase II at an estimated total amount of Rs. 250 Crore.

In the above context, the undersigned is directed to say that the Governor has been pleased to accord administrative approval to the proposal of "Planning, Design and Construction of Government Medical College and Hospital at Uluberia" (Under CSS Phase-II) at the cost of Rs. 250 Crore {inclusive of Rs 4.23 Crore [as utility service charge] & Rs. 9.45 Crore [as Administrative Charges WBMSCL]}.

The construction work will be done by M/s MACKINTOSH BURN LIMITED, identified as L1 bidder.

Fund will be released in due course out of Fund received from Govt. of India as Central Share and consequential State Share (in ratio of 60:40).
